Average Annualized Returns

This report shows performance as of the most recent month- and quarter-end for Thrivent Mutual Funds and Thrivent Church Loan and Income Fund, Class S shares. Performance data for one year or greater are annualized; periods less than one year are not annualized.

Annualized total returns reflect changes in share prices, the deduction of net operating expenses, the reinvestment of all dividends and capital gains, and the effects of compounding. Since performance varies by year, annualized total returns, which assume a steady rate of growth, differ from the Fund's actual total return for the year indicated.

30-Day SEC Yield is a standardized yield calculation developed by the Securities and Exchange Commission (SEC). It captures the dividends and interest earned during the period, after the deduction of the Fund's expenses. Data is for the 30-calendar-day period ending the date of this report.

Thrivent Money Market Fund Yield: 7-Day Current Yield is the yield generated by an investment in the Fund over a 7-day period ended on the date of the calculation and expressed as an annual percentage. 7-Day Effective Yield is calculated similarly to the 7-day current yield, except that the effective yield assumes that income earned from the Fund's investments is reinvested and generating additional income. It is expressed as an annual percentage. The yield quotation more closely reflects the current earnings of the Thrivent Money Market Fund than the total return quotation.

Thrivent Church Loan and Income Fund is a closed-end "interval fund" which is different from a mutual fund in specific ways. The Fund is only available to purchase through a financial professional. As an interval fund, the Fund can be purchased daily but redeeming money from the Fund is only offered at specific times. Limited liquidity is provided to shareholders only through the Fund's quarterly offers to repurchase between 5% to 25% of its outstanding shares at net asset value (subject to applicable laws and approval of the Board of Trustees). There is no secondary market for the Fund's shares and none is expected to develop. Investors should consider shares of the Fund to be an illiquid investment. If a repurchase offer is oversubscribed, your redemption request may be prorated. There is no assurance that investors will be able to redeem shares when and in the amount desired.
