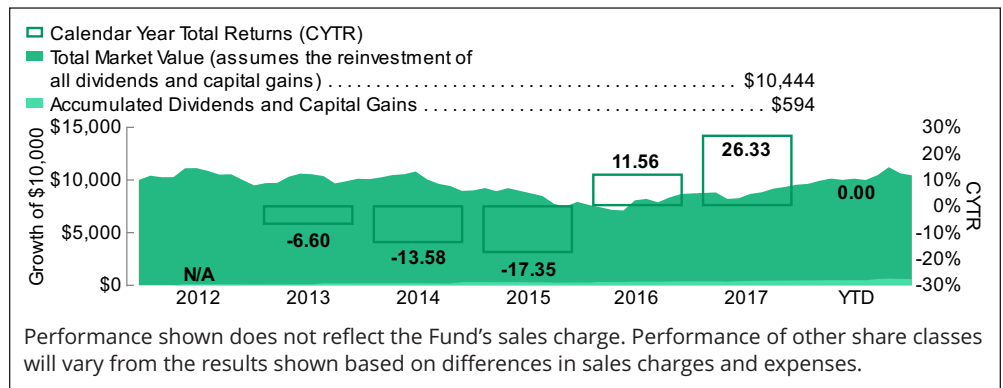
**Fund Description**

Thrivent Partner Emerging Markets Equity Fund invests primarily in companies of countries that are considered to have an "emerging" or "developing" stock market. According to the United Nations, more than fifty percent of the world's population resides in emerging market countries, such as Brazil, Russia, India and China. Emerging market countries often have younger, growing populations, an expanding middle class, developing infrastructure and improving monetary and fiscal policies. These factors help contribute to faster growth rates compared to their developed country counterparts, but with more volatility.

**Investment Strategy/Process**

The Fund invests primarily in the equity securities of companies based in emerging stock markets. It uses a disciplined investment process which uses proprietary research to seek to identify quality companies (based on factors such as strength of management and business), that trade at reasonable valuations based on factors such as earnings growth and other key financial measurements.

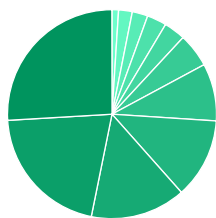

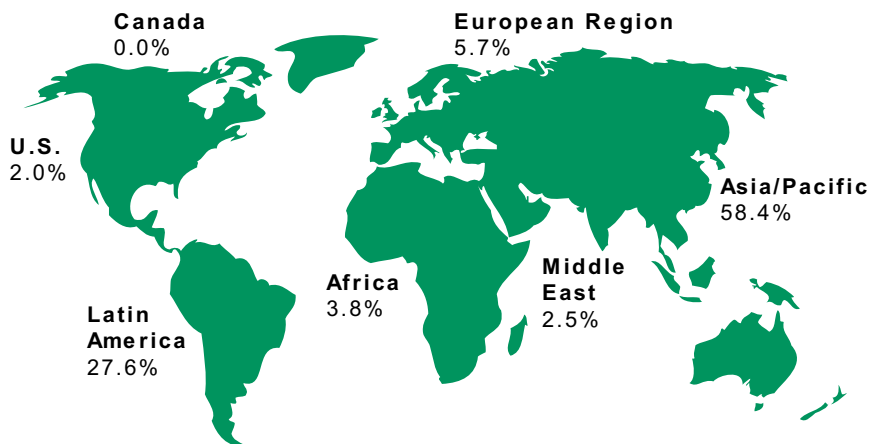
