Fund Description

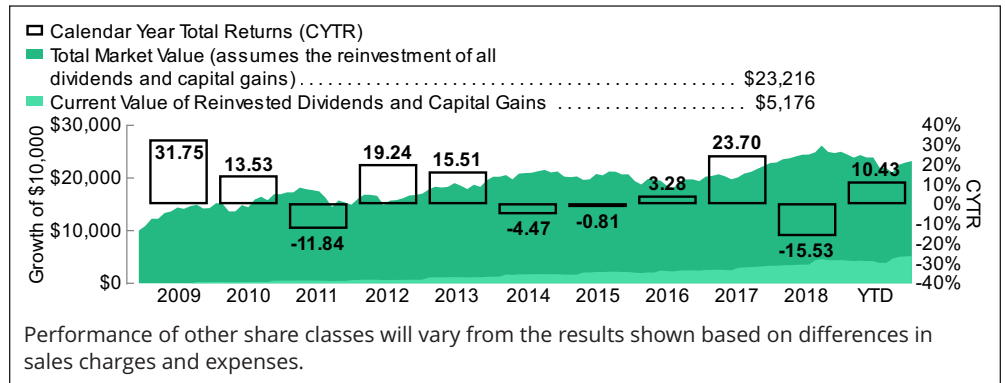
Thrivent Partner Worldwide Allocation Fund is a well-diversified portfolio of global securities that is managed by a variety of different sub-advisors. It is designed to provide investors with an all-in-one solution for international investing and includes allocations to large, mid and small-cap international companies, across the growth, value, and core investment styles. The Fund also provides exposure to the emerging market equity and emerging market debt markets. Investors should be comfortable with the high level of volatility that is associated with emerging market investing.

Effective April 30, 2019, Thrivent Partner Worldwide Allocation Fund will be renamed Thrivent International Allocation Fund. See prospectus supplement for more information.

Investment Strategy/Process

The portfolio management team seeks to achieve its objective by investing primarily in a portfolio of broadly-diversified international equity and debt securities. The Fund has a long-term target allocation of approximately 30% international large-cap growth, 30% international large-cap value, 15% international small- and mid-cap companies, 15% emerging-market equity and 10% emerging-market debt securities. The Fund utilizes a variety of sub-advisors to manage the various asset classes. Thrivent Asset Management makes asset allocation decisions among the various asset classes and selects and monitors the sub-advisors on an ongoing basis. Each of the portfolio management teams seeks to add value through security selection and active management, and monitors risk in an effort to build a well-diversified portfolio.

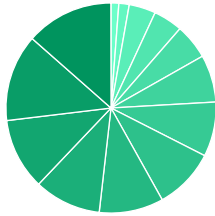

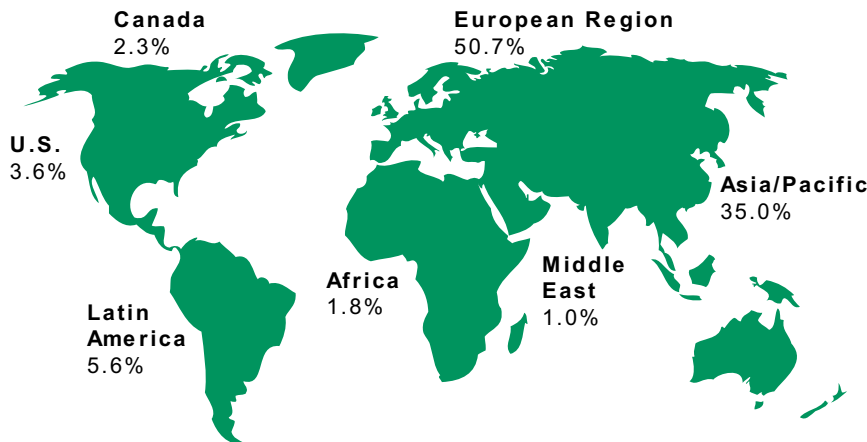
