14 Describe the organizational action and, if applicable, the date of the action or the date against which shareholders' ownership is measured for the action ▶

THRIVENT NATURAL RESOURCES FUND PAID CASH DISTRIBUTIONS ON DECEMBER 30, 2013, TO ITS SHAREHOLDERS ON RECORD AS OF DECEMBER 27, 2013. THE FUND HAS DETERMINED THAT A PORTION OF THE CASH DISTRIBUTIONS EXCEED THE CURRENT AND ACCUMULATED EARNINGS AND PROFITS OF THE FUND FOR THE TAX YEAR ENDED DECEMBER 31, 2013. THEREFORE, A PORTION OF THE CASH DISTRIBUTIONS WILL BE CONSIDERED RETURN OF CAPITAL TO THE SHAREHOLDERS.

THE RETURN OF CAPITAL RESULTS IN A REDUCTION IN COST BASIS OF THE SHARES HELD BY THE SHAREHOLDERS.

15 Describe the quantitative effect of the organizational action on the basis of the security in the hands of a U.S. taxpayer as an adjustment per share or as a percentage of old basis ▶

THE FUND PAID CASH DISTRIBUTIONS OF \$.04067 PER CLASS A SHARES AND \$.07302 PER INSTITUTIONAL CLASS SHARES ON DECEMBER 30, 2013. THE RETURN OF CAPITAL PORTION FOR BOTH CLASSES OF SHAREHOLDERS IS \$.02055 PER SHARE, OR 50.53% OF CLASS A SHARE DISTRIBUTIONS AND 28.14% OF INSTITUTIONAL CLASS SHARE DISTRIBUTIONS.

THE SHAREHOLDERS' BASIS IN SHARES OF THE FUND IS REDUCED BY \$.02055 PER SHARE. ANY REMAINING AMOUNT IN EXCESS OF BASIS IS TAXED AS CAPITAL GAIN TO THE SHAREHOLDERS.

16 Describe the calculation of the change in basis and the data that supports the calculation, such as the market values of securities and the valuation dates ▶

THE RETURN OF CAPITAL PORTION OF THE DISTRIBUTIONS IS CALCULATED AS THE DISTRIBUTIONS PAID WHICH EXCEEDED THE FUND'S CURRENT AND ACCUMULATED EARNINGS AND PROFITS AS OF DECEMBER 31, 2013.

THE TOTAL DISTRIBUTIONS LESS THE AMOUNT ATTRIBUTABLE TO EARNINGS AND PROFITS IS RETURN OF CAPITAL.

IT HAS BEEN DETERMINED THAT \$.02055 PER SHARE IS RETURN OF CAPITAL, A REDUCTION IN COST BASIS TO THE SHAREHOLDERS.
