THRIVENT GROWTH AND INCOME PLUS FUND PAID CASH DISTRIBUTIONS AS FOLLOWS:

- ON MARCH 31, 2016, TO ITS SHAREHOLDERS ON RECORD AS OF MARCH 30, 2016
- ON JUNE 30, 2016, TO ITS SHAREHOLDERS ON RECORD AS OF JUNE 29, 2016
- ON SEPTEMBER 30, 2016, TO ITS SHAREHOLDERS ON RECORD AS OF SEPTEMBER 29, 2016
- ON DECEMBER 29, 2016, TO ITS SHAREHOLDERS ON RECORD AS OF DECEMBER 28, 2016

THE FUND HAS DETERMINED THAT A PORTION OF THE CASH DISTRIBUTIONS EXCEED THE CURRENT AND ACCUMULATED EARNINGS AND PROFITS OF THE FUND FOR THE TAX YEAR ENDED DECEMBER 31, 2016.
